



STREET FAIR APPLICATION (APRIL 18, 2015)

General Information:

Gospel and Gullah in Georgetown Street Fair will take place Saturday, April 18, 2015, in downtown Georgetown, SC. Festival hours are from 11:00 AM – 3:30 PM. **NOTE: This is an outdoor street fair and will be held rain or shine.** Set up will begin at 8:00am. Vendors will need to check in at the GGG Information Booth at the corner of Prince and King Streets in Georgetown. (For GPS directions, use the address 129 King Street, Georgetown, SC 29440.) Clean up begins at 3:45pm.

NonProfit Vendor Fees:

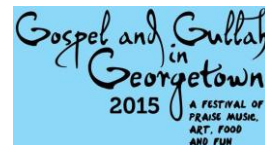
- **\$10 Event fee (NO CHARGE FOR GCOST MEMBERS/501C3s SERVING CHILDREN)**
- **\$25 REFUNDABLE** Clean up deposit. This is returned to vendors at the end of the event upon inspection of the vendor space. The deposit will not be refunded to the vendor if the vendor space is not left in the clean condition in which it was first occupied on the morning of the fair.
- Vendor provides own canopy, tables and chairs and garbage bags. Mitney has some tables and chairs available for rent for the day. The rates are \$10 per 3' X 3' square table, and \$5 per chair.
- All fees must be submitted at the time of application payable to The Mitney Project, PO Box 349, Georgetown, SC 29442

Application Procedure:

- Completed application and payment must be received by March 30, 2015.
Completed application is:
 - 1) signed and dated application form
 - 2) completed liability waiver
 - 3) cash, money order or personal check payment for all applicable fees payable to The Mitney Project
- Vendor space numbers will be assigned on the morning of the event upon vendor check-in at the information booth.

General Rules:

- The festival does not allow the use of **generators**.
- All display areas must be placed within your 10' X 10' space. Items may not extend into the street more than 10 feet from the curb or extend behind your booth space.
- **Sidewalks must be kept open and clear at all times.**
- This is a family event. No flammable or harmful items may be displayed.
- The Festival is not responsible for any loss or theft incurred by any vendor.
- Vendors are responsible for removing all trash from their area at the event's close in the evening and may use Festival trash receptacles for its disposal.
- **Vendors are responsible for leaving their space clean after the event. A cleaning deposit will be charged. This deposit will be returned upon final inspection of the site.**

- ◆ Cash, Money Order or Check for the appropriate amount made payable to The Mitney Project

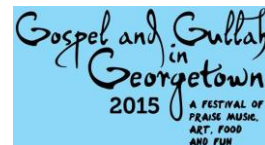
